



**WILSON MEMORIAL DAY FAIR CONTRACT**  
**Lake Street (Rt. 425)**  
**Wilson, New York 14172**

**May 27, 2024 (8:00 a.m. to 4:00 p.m.)**

The undersigned dealer hereby does lease and rent from the Wilson Historical Society on Lake Street (Rt. 425) Wilson, New York a 25' x 20' space on the Wilson Museum grounds to exhibit and sell antiques, or other items for one day, **MAY 27, 2024**, beginning at 8:00 a.m. for the sum of \$50.00 per space. Return this contract no later than **APRIL 15, 2024** if you want to keep your assigned spot from Memorial Day Fair 2023. **NO REFUNDS** will be granted after **APRIL 15, 2024** and any contracts postmarked after April 15<sup>th</sup> the fee will be \$60.00. Approved food and beverage vendors charge will be \$500.00 per space. Water and Power will be available on a limited bases for Food Vendors only: Charge will be \$25.00 for water and \$25.00 for power.

Dealer agrees to arrive before 8:00 a.m. and complete preparations for exhibit by 10:00 a.m. and to pay all expenses connected with the exhibit. Dealer agrees to stay until 4:00 p.m. Dealer agrees to remove all merchandise from leased premises before 6:00 p.m. May 27, 2024. Each dealer is responsible for clean up around their space. Please crush all cardboard and put other garbage in a plastic bag and put in appropriate dumpsters. If you wish to set up on Sunday, the only hours will be 1:00 – 4:00 p.m.

Enclosed is a map outlining space locations. If you have a reserved space, it will be written on the back of this contract. You will NOT receive a postcard confirmation. If you do not have a reserved space, please indicate your area preference and we will try to accommodate you and notify you by postcard your assigned reserved space number.

Dealer hereby agrees to be solely responsible for his or her actions as a result of this contract and all acts or omissions of his or her agents, employees, or assigns and does hereby release the Wilson Historical Society from any or all claims or damages to dealer's actions whatsoever during the occupancy of this premises. Dealer hereby agrees to indemnify and hold harmless the Wilson Historical Society from any and all claims or damages resulting from Dealers rental.

Dealer will provide own setups and know that no tables or electrical outlets will be provided. The sale of food must be approved. There will be NO sale of water or pop by field vendors other than the Wilson Historical Society and paid food vendors. Thank you! **NO PETS ALLOWED.** As this is a family-oriented fair, no obscene items are allowed. Please use good judgement. The fair goes on rain or shine.

The Wilson Historical Society shall assess the accessibility of its grounds prior to the Fair. Should all or a portion of the grounds be deemed untraversable by the Society, the Society reserves the right to relocate vendors to other nearby locations and/or to deny entry. In the event a vendor is denied entry, the Society will refund the vendor's application fee.

The Wilson Historical Society shall have the right to accept or reject any application for space. If the dealer violates any provision of this agreement, the Wilson Historical Society may, if it so elects, declare this lease void and terminated and immediately take possession of leased premises. Vendor assumes complete responsibility for collection and payment of any New York State sales tax that may be owed from the sales made by him/her on the Wilson Historical Society grounds.
